



RULES OF PARTICIPATION IN THE FESTIVAL

I. TIME

Virtual (on-line) 05.05-24.08.2021

On a regular basis - Lodz, 25-28.08.2021

Foreign delegations should come to Lodz one day earlier and they may stay one day longer.

II. PARTICIPATION IN THE FESTIVAL

1. The participants of the festival are:

- a. Children, youth and adults presenting their artistic work individually or as a group on festival stages and during the festival program events.
- b. Children and youth participating in workshops and educational activities.
- c. Youth participating in the festival projects.
- d. Specialists from various fields related to the festival programme.
- e. Young and adult volunteers.
- f. Festival audience.

2. Under age festival participants shall take part in the festival events under supervision of: teachers, trainers, workshop leaders, coordinators of the festival projects or parents.

3. Organized groups and individuals participate in the festival according to the schedule made by the Organiser.

All participants of competitions, concerts, stage presentations or other programme activities are required to be registered at the festival website www.folkoweinspiracje.pl by filling in and submitting the **FESTIVAL REGISTRATION FORM** and are to send it to the address given in the application.

4. **The Festival takes place on a regular basis as well as virtually**, each of the form requires an application form filled in.

5. Registration takes place **from 10.05.2021**.

The deadlines: **01.08.2021 for a virtual part; 15.08.2021-for a part on a regular basis**

6. Registration of a foreign ensemble or delegation should be done by the leader. Individual under age participant should be registered by the leader.



7. Of age participants are registered by themselves.
8. In case of a few groups from one institution, each group has to be registered separately.
9. Volunteers are required to individually fill in the VOLUNTEERING FORM.
- 10. Admission to the festival events require tickets or invitations –according to the information in the Festival programme, according to the requirements concerning organizing events during epidemic. One should register by means of online registrator on the festival website.**
11. The registered participant's withdrawal from the festival requires written notification to the following address info@folkoweinspiracje.pl **no later than by 7 days before the beginning of a given part of the festival.** If resignation is sent after this date, registration fee will not be reimbursed.

III.REGISTRATION FEE

1. Participants taking part on a regular basis and staying at a hostel pay the amount of PLN 50 per person per night and PLN 50 for meals a day (22 Euros).
2. Accreditation for Polish groups taking part in chosen festival events is agreed individually with the leader of the group.
3. Fees and payments for foreign participants are individually agreed with the leader of delegation.
4. The costs of transport to Lodz need to be covered by the participants on their own.
5. Transport during the festival is guaranteed by the Organiser. Foreign delegations move around by means of their own means of transport which they used in order to get to the festival or it is ensured by the Organiser.
6. The costs of insurance need to be covered by the participants on their own.
7. Registration fees and accommodation and meals payments should be made **till 15.08.2021** to the bank account of FUNDACJA PROMOCJI I WSPIERANIA TWORCZOSCI CONVIVO, address: 5/5 Traugutta street, 90-106 Lodz, bank account no: **SANTANDER POLSKA S.A. 79 1090 2705 0000 0001 1024 6980**. The transfer must specify the first and family name of the participant or the group name and "FOLK INSPIRATIONS 2021".
8. Foreign participants pay the competition fee and other payments agreed with the Organiser on the day of arrival during checking in at the Festival Office.

2. Festival participants can take part in chosen festival events on-line or on a regular basis during their stay in Lodz.

3. Participants taking part on a regular basis will participate in the ranking for: **FOLKMAN 2021, FOLKWOMAN 2021, FOLKGROUP 2021.**

4. Detailed programme of the festival, rules of virtual games and participation in rankings will be published on www.folkoweinspiracje.pl in **PROGRAMME and ZONES#FOLK**

5.Organiser reserves the right to changes in the programme due to the epidemic.

6.Festival groups prepare concert programme or street theatre performance with a repertoire related thematically to the idea of the festival:

- a. choreography groups - from 20 to 45 minutes.,
- b. vocal and instrumental groups, soloists - from 10 to 20 minutes.
- c. theatre groups - 2 presentations up to 30 minutes each

7. The Organisers will decide on the selection of songs or street performances for festival concerts.

2. Participation in the competition means taking part in the ranking for the following titles: FOKLMAN 2021, FOLKWOMAN 2021, FOLKGROUP 2021.

3. The virtual form is about a review of film material sent by participants or groups by means of wetransfer to the address: info@folkoweinspiracje.pl.

4. The participation in the on-line competition in each category is according to separate rules of participation.

5. It is necessary to register by means of a registrator on the festival website to take part in the festival.

6. There will be a Laureattes Concert GOLDEN BOAT 2021 **on 27.08.2021** during which winners of on-line competitions will be known.

7. The submission of diplomas and awards will be determined individually with each laureatte by festival office.

VI. SAFETY DURING THE FESTIVAL

1. Safety in the festival venues is guaranteed by the Organiser according to the relevant regulations in force for each of the festival venues.

2. Groups of participants should be accompanied by the minimum number of leaders specified by the relevant regulations in force. The instructor cannot be the sole group leader and cannot be the member of the group. The leaders have the overall responsibility for the presentations and safety of participants as well as an order in the dressing rooms.

3. The Organiser is not responsible for any belongings left behind in dressing rooms and rehearsal halls.

4. The organiser provides medical care to participants on site of the festival events.



5. Participants of the festival are required to have valid travel and health insurance for the whole duration of the festival or the valid insurance from school or a delegating organisation.

6. Foreign participants (parents/teachers/of age participants) are obliged to fill in appropriate declarations regarding their state of health, according to applicable regulations issued by Polish sanitary and epidemiological services and authorities .

7. Foreign delegation leader is obliged to check before the departure if the participant is healthy and do not present symptoms that may be the symptoms of COVID-19 and s/he is responsible for collecting declarations regarding state of health from participants.

8. The director of the festival reserves the right to refuse to register the participant that does not have relevant documents regarding his/her state of health.

9. The Organiser reserves the right to make changes in the rules on the basis of sanitary and epidemiological regulations in force.

VII. OTHER ORGANISATIONAL PROVISIONS
